Seasonal billings will not be eligible for Budget Billing.</p> <p><u>MINIMUM CHARGE:</u> The minimum charge shall be the greater of the service charge or the transformer capacity minimum.</p> <p>The transformer capacity minimum charge per meter per month per kVA shall be</p> <p>Where more than one consumer is served from a transformer, the minimum will be allocated to each meter in proportion to the capacity required by each, using whatever information is available to their respective requirements.</p> <p>If electric service to the location has been extended under the line extension policy, then the minimum shall be the greater of the minimum as specified in this rate or the line extension minimum as specified in the AGREEMENT FOR ELECTRIC SERVICE. This minimum shall apply to the service beyond the initial term of the contract regardless of ownership.</p> <p><u>CONNECTION CHARGE:</u> Connection or reconnection of an existing service will be made providing the consumer will pay a charge of</p> <p><u>CONDITIONS OF SERVICE:</u> New three-phase power will be supplied to farm consumers on the commercial rate.</p> <p><u>TERMS OF PAYMENT:</u> In the event the current monthly bill is not paid within twenty (20) days from the billing date, it will be delinquent. At that time, each account with a delinquent balance will be assessed a \$10.00 late charge. Bills that remain delinquent at the start of the next billing cycle, will be assessed an interest charge of 1% of the amount unpaid at that time and may also be subject to disconnection for non-payment.
