AGENDA APPROVED

WAREHOUSE FORKLIFT

Jeremiah Smith reported that the forklift that the Board authorized him to purchase is on back order. The seller offered an upgraded forklift for \$500.00 more than the original lift. It was properly moved, seconded and carried to authorize purchase of the upgraded lift.

President Schenk recessed the meeting at 11:52 a.m. for lunch and reconvened at 1:00 p.m.

AUDIT REPORT

Kevin Kelso, auditor from Jackson Thornton, presented the 2018 audit report via telephone. Y-W received an unmodified opinion. It was properly moved, seconded and carried to accept the audit report as presented.

HEADQUARTERS REPORT

Manager Loutensock reported on the status of the new headquarters building. The contractor estimates that construction will be complete by October 3, 2019. Loutensock reported on Y-W's preparations for moving to the new building.

MANAGER REPORT

Manager Loutensock reviewed the delinquent accounts and presented thank yous. He provided an AMI update. He presented the Plains Telephone, CoBank and CFC patronage statements. He also presented the CFC newsletter and board report and a letter from Joe Martin regarding his candidacy for NRECA director.

It was properly moved, seconded and carried to appoint Stuart Travis as Y-W's CFC voting delegate and Trent Loutensock the alternate.

It was properly moved, seconded and carried to appoint Roger Schenk as Y-W's voting delegate for the NRECA Board of Directors election.

GENERAL MANAGER EVALUATION

President Schenk reported that Y-W's GM search consultant will coordinate Manager Loutensock's first evaluation as part of the consultant's contract with Y-W. The Board would like to conduct the evaluation with the consultant during its next retreat.

WESTERN UNITED REPORT

Steven Schoenfeld reported on his attendance at the regular meeting of the Western United Electric Board of Directors. August sales were up 12%. Western United paid \$7.3 million in capital credits to its members. The Board admitted a new member.

CREA REPORT
